This is to inform the general public including all districts, Chiefdoms, Clans, towns and villages adjoining the forest applicant communities in Gbarpolu County, otherwise known as "Tonglay Clan Community Forestry (Kongbor, Daniels, Kotee, and Tonglay)" that the Forestry Development Authority (FDA) has approved the application of Tonglay Clan Community Forest to begin with the process of acquiring a community forest Management status in keeping with the Community Right Law (CRL) and the Community Right Regulations. This notice will be posted for the period of thirty (30) days beginning from ~~03/28/17~~ April 28 2017. The notice will be posted in all public places in every towns and villages of these applicant communities and adjacent communities for a period of thirty days. After the 30 days' notice, the FA will work with each community to find suitable date and time for the con date of the Social Economic Reconnaissance Survey in each community to further verified the information provided in the application letter and also learn about the communities' way of life.

Therefore, every member of the above communities are encouraged to please check at every public places to view the notice. The notice contain phone numbers of both community representatives and the FDA that could be used to seek any clarification about the process.

Meanwhile all adjacent communities and community members in the areas where the posting of 30 days' notice and signing of affidavit of consent will take place are encouraged to please take note and cooperate with the FDA.


